**SETTLEMENT OF \$ 125,000 FOR MAN WHO INJURED HIS WRIST ON
A DEFECTIVE RAMP AT A LOADING DOCK**

A settlement of \$125,000 was negotiated on behalf of our client who injured his wrist while pushing a hand truck which got caught in a defect on a ramp at a loading dock.

**SETTLEMENT OF \$250,000 FOR WOMAN INJURED IN AMBULETTE
ACCIDENT**

Our client, a 53 year old woman sustained injuries to her back while a passenger in an ambulette that crashed when the rear axle broke causing the driver to lose control.

**SETTLEMENT OF \$235,000 FOR WOMAN CROSSING THE STREET
WHEN HIT BY CABLE VAN**

A woman who was walking in the crosswalk was struck by a cable company van making a turn when the driver was blinded by sun glare. Our client injured her wrist requiring surgery.

**\$200,000.00 RECEIVED AT TRIAL BY MAN WHO SLIPPED AND FELL
ON SIDEWALK**

A man who slipped and fell due to water flowing across the sidewalk causing a hidden ice condition received \$200,000.00 at trial for his broken ankle from the property owner.
