2012 CASES OF NOTE:

AIRLINE EMPLOYEE IN SHUTTLE BUS ACCIDENT WITH LIMOUSINE RECEIVES \$650,000 FOR INJURIES

A settlement of \$650,000 was negotiated on behalf of our client who was injured at LaGuardia Airport when the shuttle he was riding in to the employee parking lot was hit by a limousine. He sustained injuries to his shoulder and knee.

WOMAN RECEIVES \$228,000 FOR INJURIES SUSTAINED IN CHAIN COLLISION

A settlement of \$228,000 was negotiated on behalf of our client who was injured while driving home in the Bronx when her car was hit from behind into the car stopped in front of her. She had sustained injuries to her back.

MAN RECEIVES \$150,000 FOR BROKEN ANKLE

Our client, a 57 year old man received \$150,000 for a broken ankle sustained when he slipped and fell in front of a bank building due to ice on the sidewalk.

CASE SETTLED FOR \$650,000 AT MEDIATION

A mediated settlement was reached in the amount of \$650,000.00 for our client who was a passenger in a bus which was struck by another bus while stopped at a traffic light in Manhattan.

STORE SECURITY GUARD ASSAULTS MAN

Our client, a man walking with a cane due to disability, was assaulted by a supermarket security guard for getting his shopping cart stuck in the wrong checkout aisle. A settlement of \$92,500.00 was obtained during jury selection in Queens County.

WOMAN RECEIVES \$275,000.00 MEDIATED SETTLEMENT

Our client received \$275,000.00 in a mediated settlement for a broken arm sustained due to a trip and fall on a broken and uneven sidewalk near her apartment building in Manhattan.

RACE DISCRIMINATION CASE SETTLES FOR \$500,000.00

Construction workers who endured hostile work environment and racial epithets receive settlement of more than \$500,000.00.

WOMAN WHO WAS DENIED PROMOTIONS AT CITY HOSPITAL RECEIVES AWARD.

Our client who was in her early 60s was denied promotion at City Hospital. She was awarded twice her yearly salary to settle her age discrimination claims in Federal Court lawsuit.
